This was an extremely bullish week for stocks despite seeing low relative volume across the board. However, political headlines overshadowed these gains, which caused hype to resurface surrounding a potential COVID-19 stimulus. Macroeconomic data was in-line with expectations and did not show any significant improvement.

Bowser stocks (up 5.8% for the week) had a huge week with small stocks as a whole. Momentum movers **ENG**Global Corp. (ENG) and **TOMI Environmental Solutions** (TOMZ) led the way with booming volume. TOMZ has maintained momentum after announcing its uplisting to the NASDAQ Capital Markets.

Company Headlines

- **Monday: MamaMancini's (MMMB)** engaged B. Riley Securities to assist in the exploration and evaluation of strategic alternatives for enhancing shareholder value.
- **Tuesday: BAB (BABB)** reported a decrease in 3QFY20 revenue to \$624,000 from \$793,000 in the same period last year.
- **Wednesday: HC2 Holdings (HCHC)** commenced its previously announced \$65 million common stock rights offering.
- **Thursday: TOMI Environmental (TOMZ)** expanded its commercial division due to increased demand.

Bowser Notes

ENGGlobal (ENG) shares surged higher on extremely high volume on Wednesday. There was no catalyst moving the stock, but the stock managed to hold the majority of its gains. Traders were clearly the driving factor considering the stock traded ten times its average volume. Moving forward, we would like to see the company's growth maintain and for the stock to base above \$1.33 per share.

TOMI Environmental Solutions (TOMZ) continued to bounce back following the uplisting news last week. The recent headline highlighting continued growth was insignificant and did not bring anything new to the table. While we normally try to ignore that type of press release, the company's transparency is appreciated due to the stock's volatility.
